SPECIAL MEETING MINUTES 333 South Beaudry Avenue, Board Room 1:00 p.m., Tuesday, February 5, 2019

The Board of Education of the City of Los Angeles, acting as the Governing Board of the Los Angeles Unified School District, met in special session on Tuesday, February 5, 2019, at the Los Angeles City Board of Education Administrative Offices, Board Room, 333 South Beaudry Avenue, Los Angeles, California.

Opening remarks were heard from Ms. Mónica García regarding the passing of former LAUSD Superintendent, Dr. Michelle King, and the meeting was called to order at 1:07 p.m.

Ms. Vivian Ekchian, Deputy Superintendent, on behalf of the entire Los Angeles Unified community, expressed the profound loss collectively felt by the passing of Dr. Michelle King. She spoke briefly about Dr. King's life and career with LAUSD. She presented a tribute video in honor of Dr. King. Following the video, Ms. Ekchian said that the family of Dr. King asked, in lieu of flowers, donations be made to the Dr. Michelle King Memorial Scholarship Fund available to graduating seniors of the Girls Academic Leadership Academy, Dr. Michelle King School for STEM. The following resolution was postponed to the Regular Board meeting of February 19, 2019:

Mr. Melvoin, Dr. Vladovic – Empowering Schools and Teachers with Choice of Employment (Res-015-18/19) (Noticed December 11, 2018)

Whereas, The Los Angeles Unified School District is dedicated to ensuring that every student has access to a high quality education in a positive school environment shaped by dedicated and mission-driven professionals;

Whereas, The District applauds and respects the tireless dedication of educators and other school staff who deserve agency to make professional decisions about their own careers;

Whereas, The District applauds and supports the capacity of school leaders and school site decision-makers to select, support, and manage teachers who are aligned with and committed to a common, local vision for success at each District school;

Whereas, A strong and aligned team of teachers and school leadership promote student academic success and college-readiness; now, therefore, be it;

Resolved, That no teacher shall be employed at a school without the mutual agreement of the teacher and the school site decision-maker, subject to legal or contractual requirements (such as reasonable accommodations for teachers with disabilities); and, be it finally

Resolved, That the Superintendent amends or modifies any policies or practices and negotiate contractual obligations where necessary to ensure that by the 2019-2020 school year employment of all Los Angeles Unified School District teachers will be upon mutual agreement of the employee and the school site decision-maker, subject to legal or contractual requirements. The Superintendent will report to the Board within 90 days outlining efforts to ensure implementation of this resolution.

Dr. McKenna, Ms. Gonez, Mr. Melvoin, Mr. Schmerelson, Dr. Vladovic, Ms. Garcia – Celebration of Black History Month 2019 (Res-019-18/19) (Waiver of Board Rule 72)

Whereas, Black History Month, or National African American History Month, is an annual celebration of achievements by Black Americans and a time for recognizing the central role of African Americans in United States history;

Whereas, Carter G. Woodson, a Harvard trained historian, like W.E.B. DuBois before him, believed that truth would not be denied and that reason would prevail over prejudice, and as a result announced "Negro History Week" in 1925 to raise awareness of the contributions of African Americans;

Whereas, It is commonly stated that Carter G. Woodson selected February as the month to host "Negro History Week" because it encompasses the birthdays of two great Americans who played a prominent role in shaping black history, namely Abraham Lincoln and Frederick Douglass, whose birthdays are February 12th and 14th respectively;

Whereas, Carter G. Woodson believed that history was created by great people and not simply great men; he envisioned the study and celebration of Black people as a race, not simply as the producers of great men and emphasized the contributions of countless Black men and women who contributed to the advancement of human civilization;

Whereas, Since 1976, the commemoration was extended from a week-long event to the entire month of February;

Whereas, Every United States President has officially designated the month of February as Black History Month and other countries around the world, including Canada and the United Kingdom, also devote a month to celebrating Black history;

Whereas, The legacy of Carter G. Woodson lives on in the continued work of the Association for the Study of African American Life and History (ASALH), an organization now in its Centennial Year;

Whereas, The 2019 theme for Black History Month established by the ASALH is "Black Migrations";

Whereas, Over the past century and a half, Black American life, history, and culture have become major influences throughout America in music, art, literature, politics, athletics, education, military service, and diplomacy and has become appreciated by the global community; and

Whereas, The respect that fellow citizens have for one another determines the values of our country and reinforces the premise that Black lives matters; now, therefore, be it

Resolved, That the Governing Board of the Los Angeles Unified School District recognizes February as National Black History Month;

<u>Resolved</u> further, That the Board acknowledges that all people of the United States are beneficiaries of the wealth of history given to all by Black culture; and, be it finally

<u>Resolved</u>, That the Superintendent will work with educators, librarians, all the schools of the District, and the community to recognize and celebrate this month with appropriate programs, ceremonies, and activities that generate in-depth discussion of the complex factual history of the United States and the legacy of Black Americans.
