(Renewal Charter Petition for Central City Value) Recommends approval of the renewal petition for Central City Value, for 5 years, to serve up to 480 students in grades 9-12 located at 221 North Westmoreland Avenue in Los Angeles.
2. Board of Education Report No. 302 – 17/18 **ADOPTED**  
Charter Schools Division  
(Renewal Charter Petition for Ivy Bound Academy Math, Science, and Technology Charter Middle 2) Recommends approval of the renewal petition with benchmarks for Ivy Bound Academy Math, Science, and Technology Charter Middle 2, for 5 years, to serve up to 240 students in grades 5-8 located at 20040 Parthenia Street in the Northridge area of Los Angeles.
