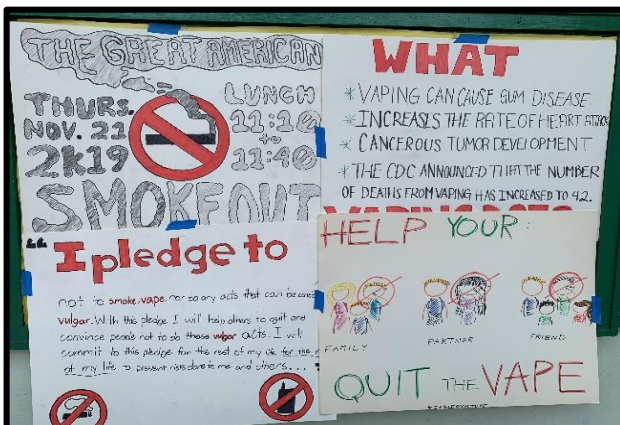




## October 6, 2020 - Board Meeting Highlights

### GRANT SUPPORTS TOBACCO USE PREVENTION AND INTERVENTION

- Seeking approval to accept a three-year \$6,978,200 Tobacco Use Prevention Education (TUPE) grant from California Dept. of Education to address student use of tobacco products. Amount  
**\$7.0M**
- Grant provides:
  - ✓ Prevention curriculum for students in health classes
  - ✓ Intervention for students most likely to use tobacco products
  - ✓ Cessation services for students currently using tobacco
  - ✓ Leadership development opportunities for students trained as peer educators
  - ✓ Education for parents and staff on the health risks associated with use of all tobacco products, e.g., cigarettes, vaporizers
- At 101 schools – 49 middle and 52 high on 94 campuses.
- Impacts 103,000 students, 16,000 school staff and 13,000 parents and community members.





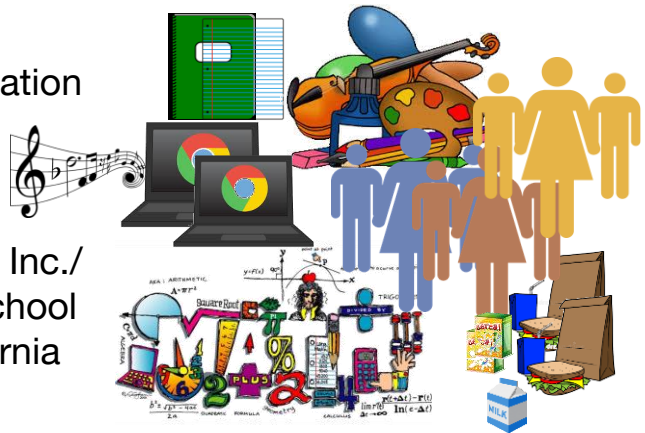
